

# PC\*MILER® Product Line END-USER LICENSE AGREEMENT

- 1. Grant of License: Subject to the terms, conditions, use limitations and payment of fees as set forth herein, ALK Technologies, Inc. ("ALK") grants the end-user ("you") a non-assignable, non-transferable, non-exclusive license to install and use the PC\*MILER solution(s) (including traffic data and fuel subscriptions) you have purchased ("PC\*MILER") on a single personal computer. The PC\*MILER software, data and documentation are provided for your personal, internal use only and not for resale. They are protected by copyright held by ALK and its licensors and are subject to the following terms and conditions which are agreed to by you, on the one hand, and ALK and its licensors (including their licensors and suppliers) on the other hand.
- 2. <u>Title</u>: You acknowledge that the PC\*MILER computer programs, data, concepts, graphics, documentation, manuals and other material owned by, developed by or licensed to ALK, including but not limited to program output (together, "program materials"), are the exclusive property of ALK or its licensors. You do not secure title to any PC\*MILER program materials by virtue of this license.
- 3. <u>Copies</u>: You may make one (1) copy of the PC\*MILER program materials, provided you retain such copy in your possession and use it solely for backup purposes. #### 1.0 Introduction

Congratulations! By purchasing a PC\*MILER product, you have made a cost-effective investment in high quality software that is simple to learn and easy to use. PC\*MILER-CICS uses simple-to-follow screens and requires minimal keystrokes to generate mileage information. In a matter of seconds you can calculate shortest, practical, national network and toll-avoidance miles, and determine cost and time estimates. Your calculations can include up to 10 stops.

PC\*MILER-CICS utilizes a unique distributed processing solution. This solution maximizes the efficiency of your on-line transactions by "farming out" repetitive mileage calculations to a dedicated PC. With PC\*MILER-CICS, you can benefit from having a seamless mileage interface with your transportation management system. ALK provides COBOL source code to the end-user to customize and integrate PC\*MILER with other transportation management software. An interface has been developed by ALK Technologies, Inc. for Distribution Sciences, Inc., to provide mileage to DSI's Base Rate<sup>®</sup> system for on-line and batch processing.

## 2.0 Hardware and Software Requirements

Because PC\*MILER-CICS and MVS/BATCH employs a distributed processing solution, the following additional hardware is required to use the software:

- A dedicated PC with a 1.5-2 GHz processor and a minimum 512 MB of RAM (1 GB recommended).
- Communication software from Zephyr Development Corporation, which
  can be downloaded using the link given below. The product is called
  PASSPORT PC TO HOST via TN3270. The PC\*MILER-CICS
  application uses the HLLAPI api to transfer data between the PC and
  the mainframe. HLLAPI (High Level Language Application Program
  Interface) is the industry standard method to interface Windows PC
  applications with host applications via 3270 terminal emulation. ALK
  Technologies does not sell or provide technical support for the TN3270
  emulation software.

After the PASSPORT PC TO HOST and the PC\*MILER-CICS products are installed, you need to ensure that the PC\*MILER-CICS application can find the PASSPORT PC TO HOST hllapi dll by doing the following:

- 1. Search for the folder that contains the WHLLAPI.DLL and search for the folder that contains the CICS.exe.
- **2.** Then, copy the WHLLAPI.DLL file from the PASSPORT folder to the folder that contains CICS.exe, and rename this copied file to "HLLAPI32.DLL".

## 6.0 Starting and Stopping the Interface

The software you installed on your dedicated PC will automatically start the interface and the MultiProtocol Workstation for Windows software when the PC is turned on.

The key3270.txt file contains logon strings that will be keyed to the host one line at a time. These strings are usually the user ID, password, and any other logon strings necessary to logon to the host. 3270 command keys such as **<Enter>** or function keys are preceded with an @ sign. For example @E will simulate pressing **<Enter>** on a 3270 screen. This file can be edited at installation time, or by using the *Edit logon strings* option, located within *Logon Options* in the **File** menu.

#### Stopping the Interface

From the PC\*MILER - CICS window, choose *Exit* from the **File** menu.

## 7.0 Using PC\*MILER for CICS

To use PC\*MILER - CICS, start the transaction PCM1. The following screen will appear:

At the top of the main entry screen are several routing options settings that determine which type of miles will be generated when you process a route. As shown, "S" is the default setting. Other options include: <P> will instruct PC\*MILER to generate practical miles; <S> will instruct PC\*MILER to generate shortest miles; <N> will instruct PC\*MILER to generate miles calculated using the National Network, which is designed for larger trucks; <T> will instruct PC\*MILER to avoid toll roads as much as possible. To change the type of miles generated, type over the current setting. (See the main PC\*MILER User's Guide for a description of routing options settings.)

Under the routing options are function settings as follows: <R> resequences the stops you've entered to generate an optimal route, keeping the origin the same (see the **Route Optimization** section in the main PC\*MILER User's Guide for more information); <F> resequences stops in an optimal route, keeping the origin and destination the same; <H> switches to HUB mode, which treats each stop as a destination so that mileage is generated from the origin to each stop (see the **Hub Routing** section in the main PC\*MILER User's Guide). To change the function setting, type over the current setting. The default setting is a blank space.

In the middle of the screen are the stop entry fields. Enter either the city name and state abbreviations, the ZIP code, or the latitude/longitude position (example: **0333716N,1142709W**) for the stop-off locations desired. You may enter up to 10 stops.

At the bottom of the screen, the function keys used with PC\*MILER - CICS are described. These include the following: **<F3>** exits the program and returns to the main screen; **<F10>** sends the mileage inquiry request to PC\*MILER.

Once you have entered stop(s) on the main screen and initiated a mileage inquiry by pressing **<F10>**, the following screen will appear:

This display contains leg and cumulative mileage for each segment of your trip. The time and cost estimates are based on the values contained in the copy of PC\*MILER installed on your dedicated PC.

## 8.0 Using PC\*MILER With Other Transportation Software

An interface has been developed for Distribution Sciences, Inc., by ALK Technologies, Inc., to provide mileage to their Base Rate system for on-line and batch processing. Since mileage is an integral part of transportation, ALK has provided general purpose COBOL programs that can be accessed by in-house systems. The following technical overview describes how these programs can be used.

#### **Technical Overview**

The PC\*MILER-CICS system uses distributed processing techniques (i.e., the processing is split into two). The user interface or interactive software is written in COBOL and runs on the mainframe in the CICS environment. The mileage calculation software is written in C and runs on a PC in the Windows environment. The mainframe COBOL programs communicate with the PC mileage calculation software through an interface board commonly known as "3270 emulation". The interactive software on the mainframe allows multiple users to look up point to point mileage and calculate time and cost estimates for up to ten stop-off points. Additionally, ALK is providing COBOL source code so that other transportation software can access mileage information. The COBOL routines can be used for CICS on-line lookups or batch. Following is a list of the programs and a brief description of their use.




